

\*Classification 9079 consists of two alternate phraseologies (or suffixes): 9079(1), Restaurants or Taverns – all employees – including musicians and entertainers, and 9079(2), Concessionaires – dispensing food and beverage items at ball parks, racetracks, theaters, concert venues and amusement and recreational facilities. Classification 9079(2) will be changed to 9081(2), effective September 1, 2024.
